ORDER

This Criminal Original Petition has been filed to quash the proceedings in C.C.No.1049 of 2015 on the file of the learned XXIII Metropolitan Magistrate, Saidapet, Chennai, pursuant to the compromise arrived at by the parties.

2. The case is still in the stage of investigation. By passage of time, the parties have decided to bury their hatchet and compromise the dispute amicably among themselves.

3. The second respondent / Defacto complainant filed an affidavit before this Court seeking permission to compound the issue and settle the dispute. All the parties are present and identified by their respective counsel and the Police. In order to identify the respective parties, they have also produced the copies of the Aadhaar Card are made part of the record. This Court also enquired both the parties and was satisfied that the parties have come to an amicable settlement between themselves.



4. Under such circumstances, no useful purpose will be served in keeping the Calender Case pending, even though, the offences involved are not compoundable in nature. In the light of the guidelines given by the Hon'ble Supreme Court reported in 2017 9 SCC 641-(Parbathbhai Aahir @ Parbathbhai Vs. State of Gujrath), this Court in exercise of its jurisdiction under Section 482 Cr.P.C. quashes the proceedings in C.C.No.1049 of 2015.

5. This Criminal Original Petition stands allowed and as a sequel, the proceedings in C.C.No.1049 of 2015 on the file of the learned XXIII Metropolitan Magistrate, Saidapet, Chennai, is quashed and the terms of Joint Memo of Compromise shall form part and parcel of this Order. The petitioner shall pay a sum of Rs.5000/-, as costs, to the SEVALAYA, No.54, P.S.Sivaswamy Road (North), Mylapore, Chennai-600 004, Tamilnadu, India.
