This Criminal Original Petition has been filed seeking for a direction to the respondents 2 and 3 to provide adequate police protection for Shri Ponnamman and Shri Gangaianman temple festival at Idharpuram Village, Vellore District to be held between 23.06.2019 to 25.06.2019.

2.The learned counsel for the petitioner would submit that the petitioner has made a representation dated 25.03.2019 to the respondents police with regard to give adequate police protection to Shri Ponnamman and Shri Gangaianman temple festival at Idharpuram Village, Vellore District between 23.06.2019 to 25.06.2019. Since, no order has been passed, the

6. With the above directions, this Criminal Original Petition stands allowed.
