3.According to the petitioners, they could not mobilise funds to file appeal in time and hence the delay of 1753 days has

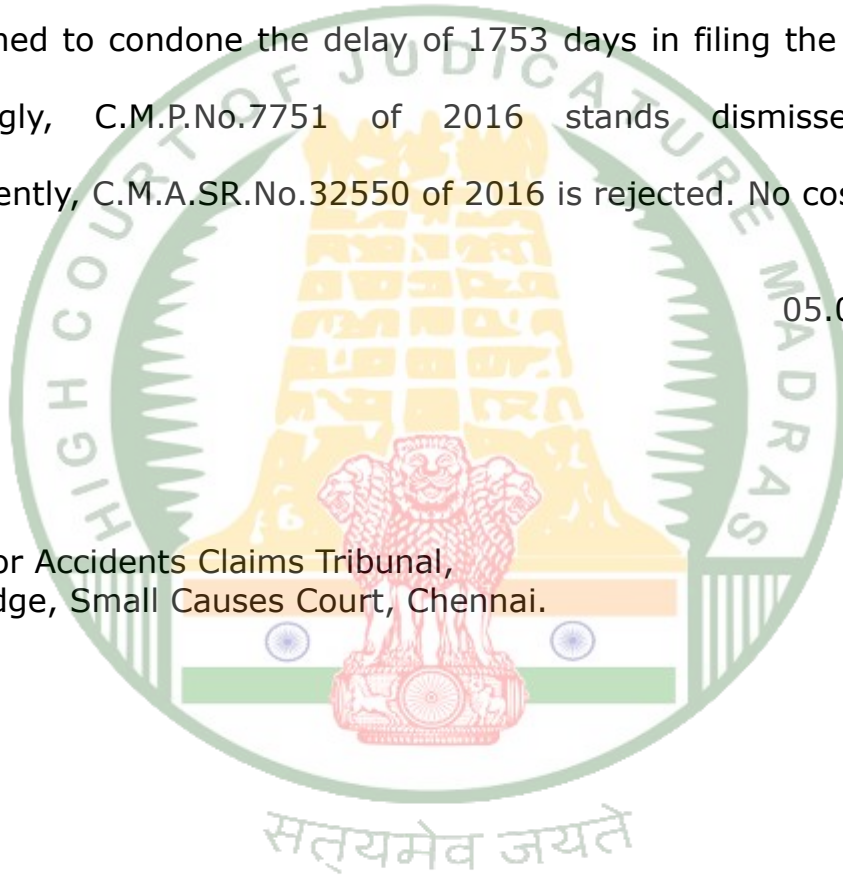

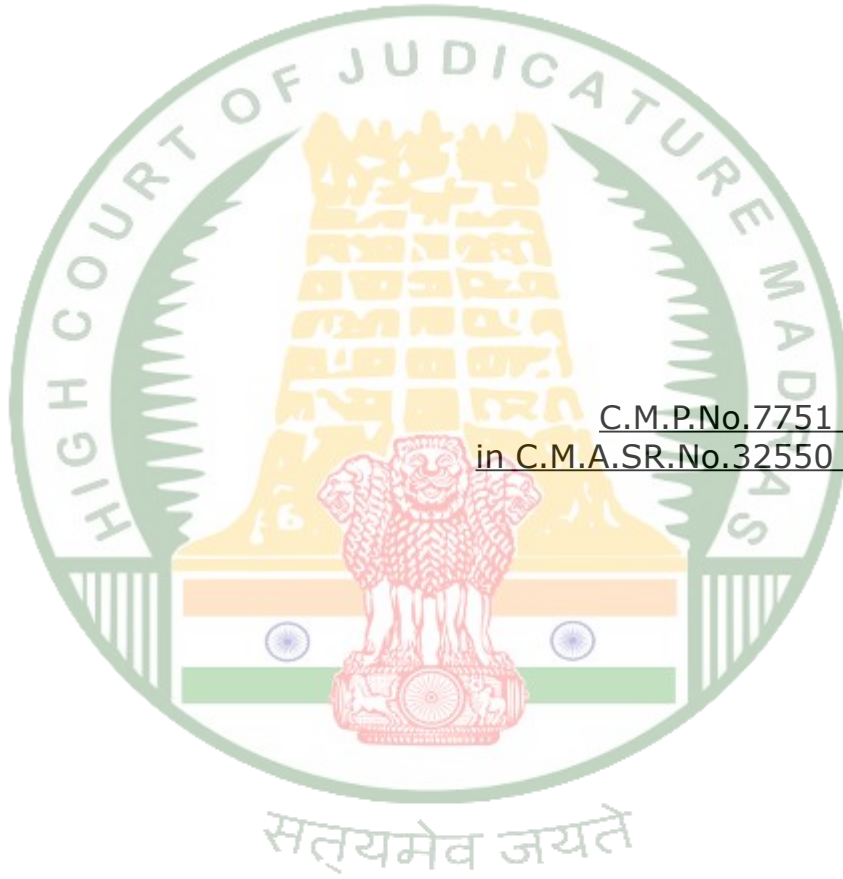
