This Court, while dismissing the earlier application filed for suspension of sentence on 14.02.2019, had directed the Registry to list the main criminal appeal for final hearing on 28.03.2019 and accordingly, it was listed. However, due to paucity of time, this Court is unable to take up the criminal appeal for final disposal.

2 Since the earlier petition seeking suspension of substantive sentence of imprisonment came to be dismissed considering the nature and gravity of the offence, this Court is not inclined to entertain this petition. Accordingly, the same is **dismissed**.

3 The Registry is directed to list the criminal appeal for final hearing on 13.06.2019.
