This Original Petition coming on this day before this Court for hearing the court made the following order:

The petitioners seek issuance of Succession Certificate in respect of the securities held by late H.Eqbal @ H.Iqbal, who died intestate on 11.09.2012.

2. According to the petitioners, they are the only legal heirs of the deceased being wife, son and daughters. The 1st petitioner has been examined as PW1. He has produced the death certificate of Sharifa Beevi mother of H.Eqbal @ H.Iqbal as Ex.P2. The marriage certificate between H.Eqbal @ H.Iqbal and Roshan Beevi [1st wife] has been produced as Ex.P3. Ex.P4 is the original legal heirship certificate of the deceased H.Eqbal @ H.Iqbal. Ex.P5 is the marriage certificate evidencing the marriage between the deceased H.Eqbal @ H.Iqbal and the 2nd petitioner. Ex.P9 is the death certificate of the Roshan Beevi viz., the 1st wife of H.Eqbal @ H.Iqbal who died on 29.04.1990.

3. From the legal heirship certificate produced as Ex.P4 it is seen that the petitioners are the only legal heirs of the deceased H.Eqbal @ H.Iqbal.

4. Considering the said evidence, this Original Petition is allowed granting Succession Certificate in respect of the securities that stand in the name of the deceased H.Eqbal @ H.Iqbal in favour of the petitioners.

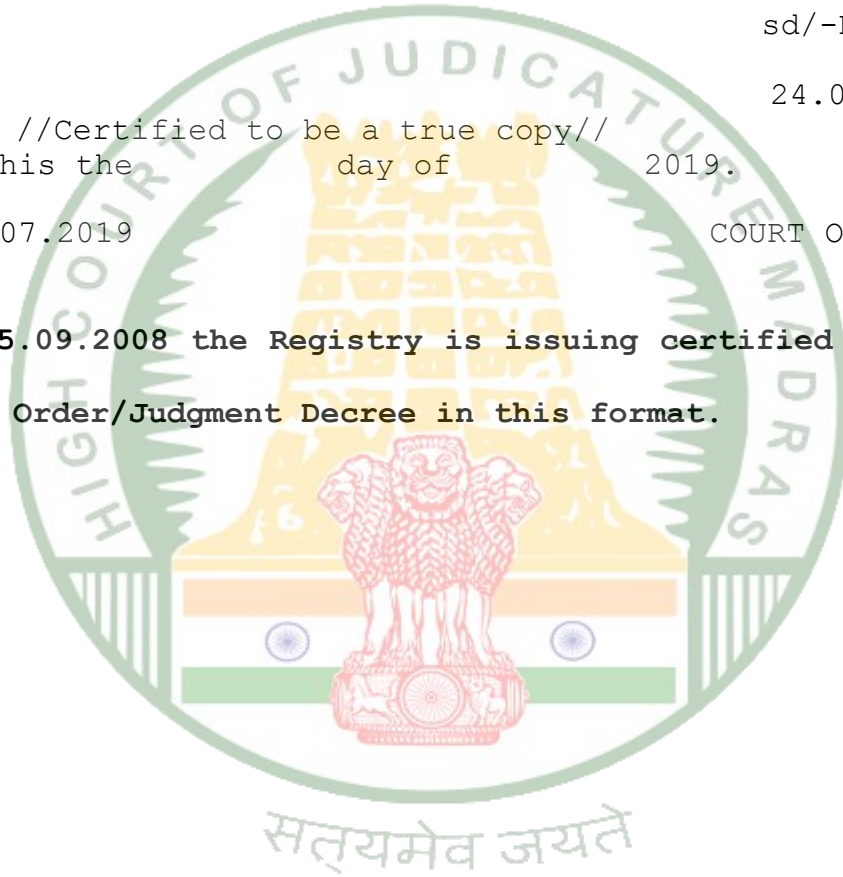
