12.01.2019 passed by the Commissioner of Police, Chennai City, Vepery, Chennai - 7 by considering the representation of the petitioner dated 23.04.2019, the wife of the detenu is before this court with this petition.

2. When the petition came up for hearing, the learned Additional Public Prosecutor submitted that the order of detention passed against the detenu had already been quashed by this court in H.C.P. No.192 of 2019 by order dated 07.06.2019 and the detenu was also released from the prison.
