(c)to direct the defendants to jointly and severally to pay to the plaintiff for costs of the suit.

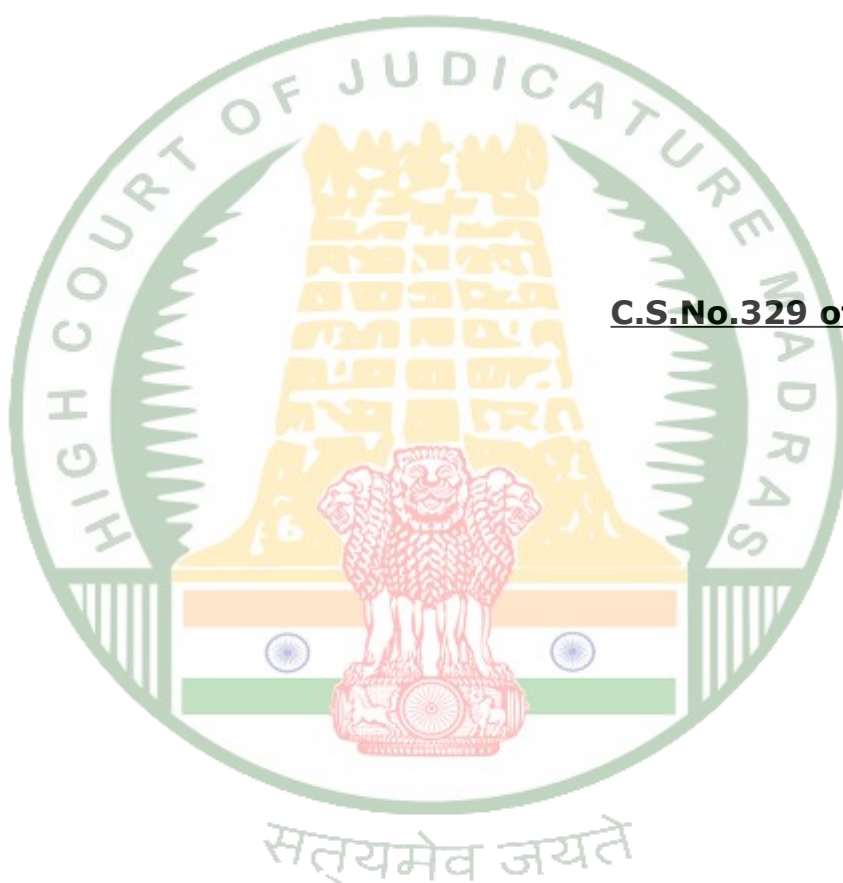
