COMMON ORDER

Heard the learned counsel for the petitioners and Mr.S.Kamalesh Kannan, learned Government Advocate, who takes notice for respondent no.1, as also Mr.P.Srinivas, learned Standing Counsel, who takes notice for respondent no.2.

2.The case of the petitioners is that they have preferred review petitions on 04.04.2019 under Section 217-K of the Tamil Nadu District Municipalities Act, 1920. The prayer of the petitioners in these petitions is that respondent no.1 be directed to pass orders on the said review petitions.
