2. The learned counsel for the petitioner would submit that the petitioner has been regularly appearing before the trial Court.

3. The learned Special Public Prosecutor for CBI would submit that the petitioner has been complying with the condition regularly.

4. Taking into consideration of the submissions made by the counsel on either side, the condition imposed on the petitioner in Crl.M.P.No.13807 of 2018 in Crl.A.No.793 of 2017 dated 12.10.2018 is modified in the following manner.

"The petitioner shall appear before the trial Court once in three months, on the first working day of the concerned English Calender month at 10.30 am, commencing from July 2019, until further orders."
