2.Learned Government Pleader (I/c.) states that respondent no.3, Tahsildar, Alandur, Chennai, is the appropriate authority to consider the representation and respondent no.3 will dispose of the representation within a period of six weeks from the date of receipt of a copy of the order in this petition. In case, respondent no.3, Tahsildar, Alandur, comes to the conclusion that jurisdiction does not vest in him, respondent no.3 will forward the representation to the appropriate authority for taking appropriate action.

In view of the statement made by the learned Government Pleader (I.c.), no further orders are required. This writ petition is, accordingly, disposed of. No costs.

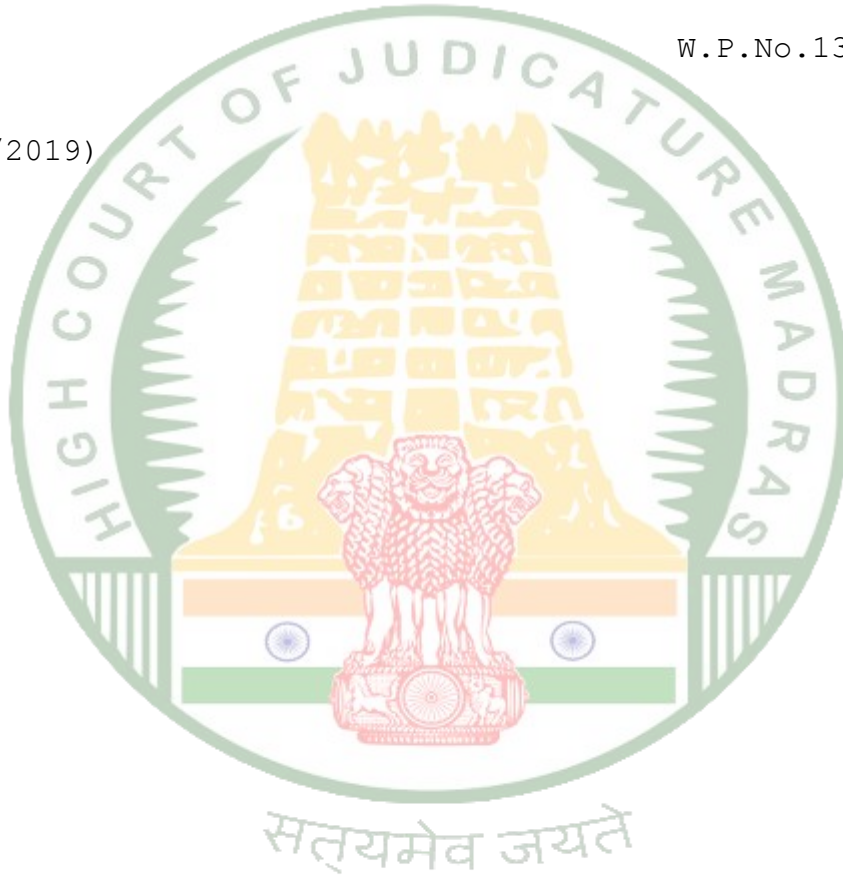
