2. The learned counsel for the petitioner submitted that the petitioner is complying the condition from the date of order. Hence, the petitioner has come forward with the present petition seeking modification of the said condition.

3. The learned Additional Public Prosecutor would submit that the petitioner has been complying with the conditions regularly.

4. Taking into consideration of the submissions made by either side, the condition imposed on the petitioner in Crl.M.P.No.17448 of 2018 dated 07.01.2019 is modified in the following manner.

"The petitioner shall report before the trial Court on the first working day of every English Calender month at 10.30 am, until further orders."
