ORDER

When it is pointed out that having regard to the nature of dispute involved, which falls under the realm of disputed questions of facts, the matter has to be decided after recording of evidence of the parties on their rival contentions and could not be redressed by invoking the public law remedy following summary procedure under Article 226 of the Constitution, Learned Counsel for the Petitioner seeks permission of this Court to withdraw the Writ Petition with liberty to resort to institution of suit before the jurisdictional Civil Court for necessary

relief by impleading necessary parties, and he has made an endorsement to that effect, which is recorded.

2. Accordingly, the Writ Petition is dismissed as withdrawn granting such liberty. Consequently, connected Miscellaneous Petitions are closed. No costs.
