In view of the above, the aforesaid condition stands relaxed and the petitioners are directed to report before the District Munsif-cum-Judicial Magistrate, Kattumannarkoil, at 10.30 a.m. on the first working day of every month until disposal of Crl.A.No.4 of 2019 and if they are not able to appear before the said Court on any day, they shall make arrangements to file an application under Section 317 Cr.P.C. and shall appear before the said Court on any other day in lieu of the date of their absence, as directed by the trial Court.
