2. This writ petition is filed to direct the 1st
respondent to consider the appeal petition filed by the
petitioner herein and pass orders.

The case of the petitioner is that on 08.05.2019, the Regional Transport Officer, Kanchipuram has passed a proceedings suspending the Driving License of the petitioner between 07.04.2019 and 06.10.2019 against which the petitioner has preferred appeal dated 20.05.2019 but according to the petitioner till date his appeal was not taken up for consideration by the Joint Commissioner, Transport Department, Chennai.
