3. When the matter is taken up for hearing, the learned Additional Public Prosecutor reports that the petitioner is arrayed as accused in Crime No.178 of 2019 and investigation is pending before the 1st respondent, the Inspector of Police, CCB-1, EDF-3, Team 21-A, Vepery, Chennai - 600 007.

4. Under such circumstances, once the regular FIR has been registered, the question of "Not to harass" will not arise. Any direction issued by this Court at this stage will amount to interfering with the investigation conducted by the respondent police.

5. Hence, the Criminal Original Petition is dismissed.
