The above petition has been filed seeking extension of time from six weeks to six months for depositing the balance amount of Rs.3 lakhs before the Trial Court to the credit of Cc.No.30/2006.

2 Heard the submissions of Mr.Babu Muthu Meeran, learned counsel for the petitioner and Mr.K.Srinivas, learned Special Public Prosecutor [CBI] appearing on behalf of the respondent.

3 Time for payment of the balance amount of Rs.3,00,000/- [Rupees Three Lakhs only] to the credit of CC.No.30/2006 before the Trial Court is **hereby extended for a period of two months from the date of receipt of a copy of this order** and if the said amount is not paid within the said period, the bail granted to the petitioner/A-3 shall stand cancelled automatically without any reference to this Court.

4 The petition is **ordered** accordingly.
