The above Writ Petitions are filed for issuance of a writ of mandamus, directing the 1st respondent herein to dispose of the representation dated 24.04.2019, submitted by the writ petitioners along with other parents, with reference to the amended Article 106 class D(ii) in proceeding No.F.110362/02/2017-18/KVS (Acad)/CBSE Result dated 05.06.2018 of Kendriya Vidyalaya Sangathan, (Min. of HRD. Deptt. Of Education, Govt. of India, New Delhi) so as to enable the ward of the writ petitioner to have the re-examination in XI standard in the failed subjects either in the same school or any other CBSE School, within the stipulated period, prescribed by this Court.

6. The petitioners are directed to send a fresh representation along with order copy of this Court to the first respondent to pass appropriate orders.
