O R D E R

The Petitioner has made a representation dated 30.05.2019
seeking to regularize the tenancy of the portion occupied by him

Special Government Pleader, on instructions, states that the

4. The Writ Petition is disposed on the aforesaid terms. Consequently the connected Miscellaneous Petition is also closed. No costs.
