The affidavit is completely bald and in the absence of iota of detail, this Court is unable to appreciate the claim of the petitioner.

3.This Court does not find any clue from the entirety of the affidavit as to what is the basis of the petitioner's claim seeking appointment in public service. Therefore, this Court is of the view that the Writ Petition as it framed is not maintainable and hence, the same is dismissed. No costs.
