Order : This petition coming on for orders upon perusing the petition and the filed in support thereof and upon hearing the arguments of M/S.V.SATHISH, Advocate for the petitioners, and of M/S.G.RAMAR, Advocate, on behalf of the Respondents the court made the following order:-

This is the second petition seeking suspension of sentence and bail. The first petition filed in Crl.MP.No.9475 of 2018 was dismissed on 26.10.2018.

2. The petitioner has been convicted and sentenced to undergo 10 years Rigorous Imprisonment under Section 6 of the POCSO Act.

3. On a reading of the statement under Section 164 Cr.P.C., and the evidence of the victim girl, it is seen that she has clearly implicated the petitioner herein in the offence. The victim girl was only aged about 12 years at the time of incident.

4. Under such circumstances, this Court does not find any sufficient reason to grant suspension of sentence and release the petitioner on bail. Hence, this Criminal Miscellaneous Petition is dismissed.
