COMMON ORDER

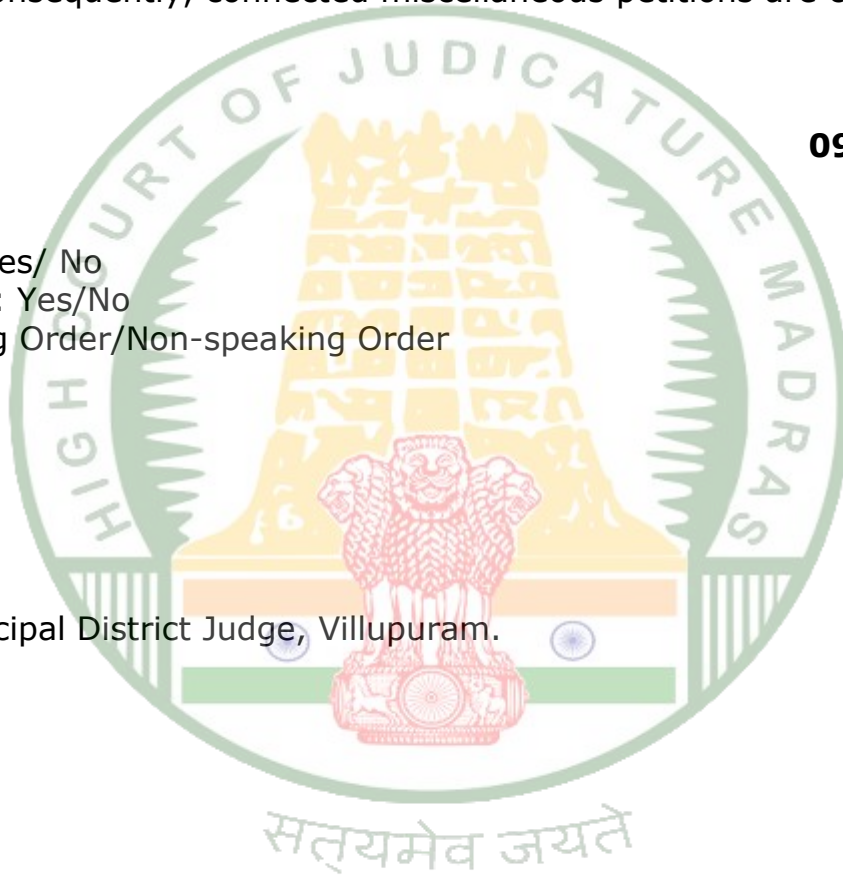

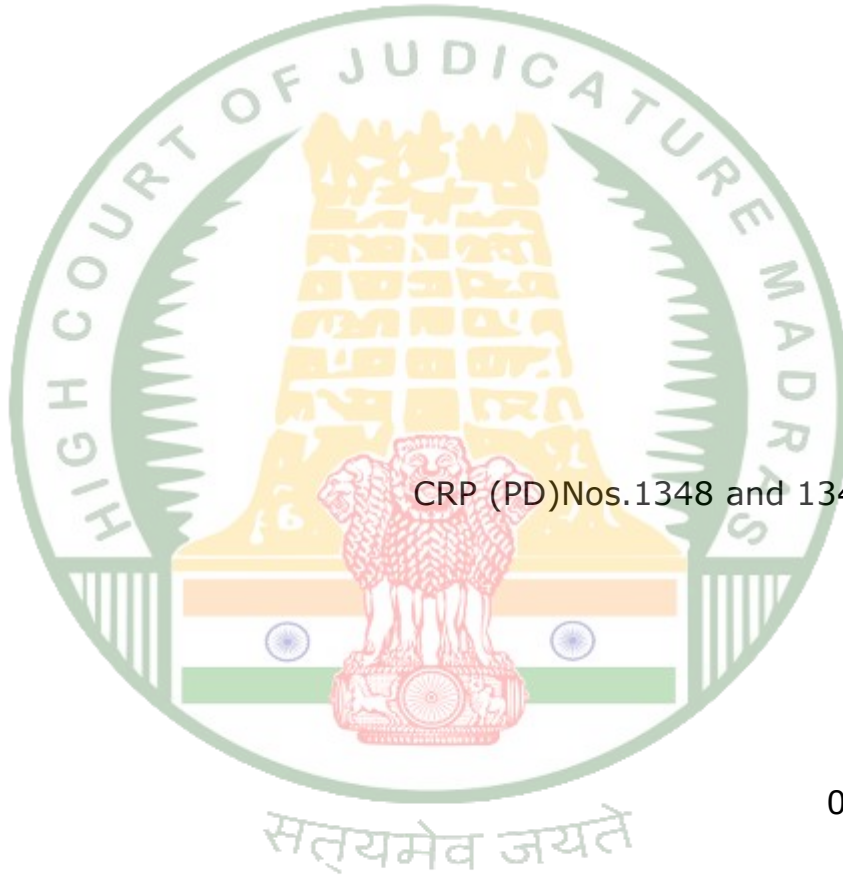
