Petition filed under Article 226 of the Constitution of India, to issue a Writ of Habeas Corpus to call for the entire records relating to the petitioner's brother detention under Tamil Nadu Act 14 of 1982 vide detention order, dated 04.06.2019 on the file of the second respondent herein made in proceedings Memo Cr.M.P.No.09/Goonda/2019/C1, quash the same as illegal and consequently direct the respondents herein to produce the petitioner's brother namely Baburaj @ Babu, S/o. Johny @ Sabeer, aged 24 years, before this Court and set the petitioner's brother at liberty from detention, now the petitioner's brother detained at Central Prison, Coimbatore.

The petitioner challenges the impugned order of detention in Cr.M.P.No.09/Goonda/2019/C1, dated 04.06.2019, detaining her brother as "Goonda", as contemplated under Section 2(f) of the Tamil Nadu Act 14 of 1982.

The learned Additional Public Prosecutor reports that the order of detention passed against the detenu has been revoked by the Government by its order in G.O.Rt.No.2416 Home, Prohibition and Excise (IX) Department, dated 08.07.2019 and he has also produced a copy of the Government Order. Recording the same, this Habeas Corpus Petition stands closed.
