2.The learned Government Advocate, on instructions, has submitted that the petitioner's earlier representation dated 19.03.2014 has been considered by the Tahsildar (SSS), Denkanikottai and the same has been rejected by proceedings in Roc.No.466/2014 dated 05.06.2014 and hence nothing further remains to be considered in this writ petition for adjudication.

3.Recording the above submission, leaving it open to the petitioner to approach the authorities concerned for seeking the benefit of Disability Pension Scheme, the writ petition stands disposed of. No costs.
