(b) For a permanent injunction restraining the Defendants 1 and 2 or their men or servants or anybody claiming through them or under them from interfering with the right of the Plaintiff to exhibit namely 'Sindhubaadh' starring Vijay Sethupathi, Anjali and Directed by S.U.Arunkumar through theatrical and digital to all providers through 4th defendant namely M/s.QUBE Digital Cinema;

(c) to pay the cost of the suit; and

(d) to grant such other relief or reliefs this Court may deem fit and proper.

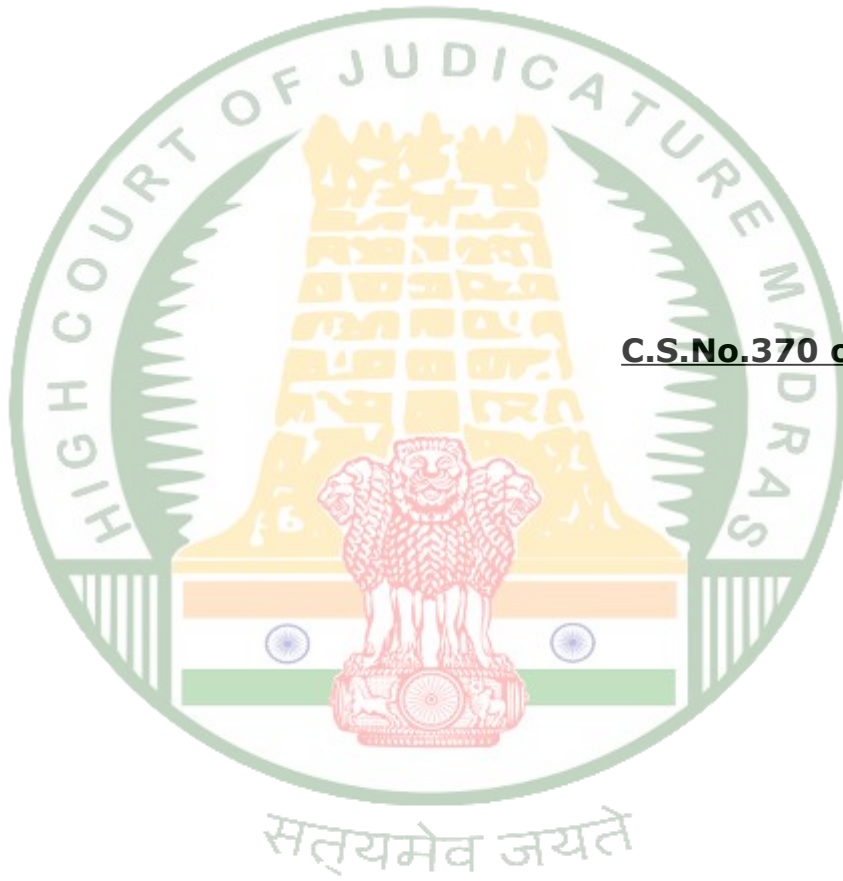
