This is the third petition seeking suspension of sentence and bail.

2. It is seen that the petitioner/accused had poured kerosene on the deceased and set fire to her. She has also given a dying declaration, despite which, the Trial Court has convicted the accused under Section 304-I IPC and sentenced him to undergo 10 years Rigorous Imprisonment and to pay a fine of Rs.1,000/- in default, to undergo 6 months Simple Imprisonment.

3. There is no change in the factual situation warranting grant of bail. Hence, this Criminal Miscellaneous Petition is dismissed.
