ORDER

The detenue was also secured. However, the parents, who are also present, were not willing to take her back. That is the reason why, we are called upon the Secretary, District Legal Services Authority to be present today. It is agreed by the parents to take back the detenue. Though there was a change of circumstances, we are of the view that it is appropriate to direct the Secretary, District Legal Services Authority, to involve a process of counselling with the detenue and her parents.

2. With the above said observation, the Habeas Corpus Petition shall stand closed.
