3. In this regard, the writ petitioners are directed to approach the Competent Authorities by submitting representations and in the event of receiving any such representations, the cases of the writ petitioners shall be considered on individual basis and the authorities are bound to pass orders on merits and in accordance with law.

4. With the above directions, the writ petitions stands disposed of. However, there shall be no order as to costs.
