(d) costs of the above proceedings; and

(e) pass such further or other orders as this Hon'ble Court may deem fit and proper in the circumstances of the case and thus render justice.

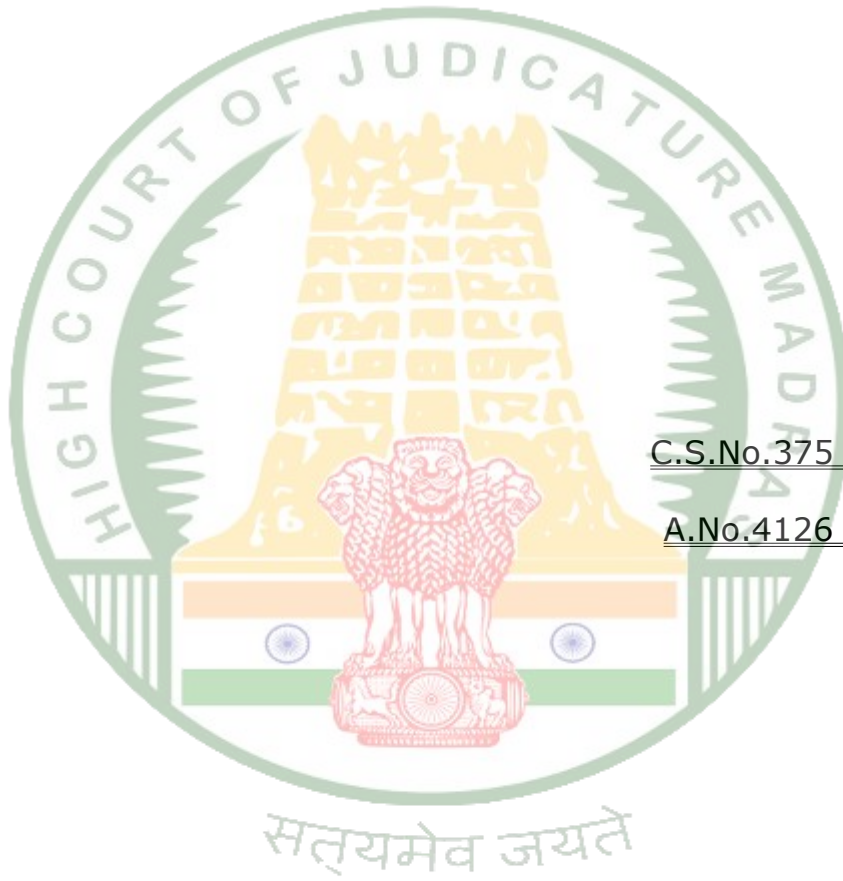
