President of Sri Ganapathy Nagar Kudieruppour Nala Sangam, 7/111, Anna Street, Sri Ganapathy Nagar, Manimedum, 83 Thandalam, Chennai 600 128, has filed the instant writ petition for a writ of mandamus directing the respondents to dispose of the representation dated 23.01.2019 and consequently prayed for a direction to the respondents to provide basic amenities/infrastructure facilities to their area.

2. According to the petitioner, people residing in the above said area are facing hardship and suffering due to lack of basic amenities, such as proper water supply, road, drainage etc. Espousing the cause of public, the above said Sangam made a representation dated 23.01.2019. Contending inter alia that no action has been taken, the petitioner has filed the instant writ petition for the relief stated supra. Considering the limited prayer, we direct Mr.E.Manoharan, learned Additional Government Pleader, to take notice.

District Collector/Chairman, District Rural Development Camp, Kancheepuram District is directed to act on the report and take necessary action.
