This Criminal Original Petition has been filed seeking to quash the proceedings in C.C.No.2030 of 2012 pending on the file of Metropolitan Magistrate No.IV, Saidapet, Chennai, having been taken cognizance for the offences punishable under Sections 3(2)a, 4(1), 5(1)a, of ITP Act (Immoral Traffic Prevention Act 1956).

2. It is seen that when the matter was posted on 24.07.2014, the learned counsel appearing for the petitioner took an adjournment and the matter was adjourned to 11.08.2014. Thereafter, for the past five years, the learned counsel has not taken any steps to list the matter. It shows that the petitioner has no interest to pursue the matter. Further it is pending for more than five years without even ordering notice. Now after the lapse of five years period,

this petition cannot be considered and this Court is not inclined to entertain this petition.
