Prayer: Criminal Original Petition is filed under Section 482 of Criminal Procedure Code, to direct the 2nd respondent To Give The Bandobust for permission to conduct the cultural programme on 27.06.2019 in the event of Gurukakalaianur Arulmighu Sri Maha Sakthi Mariamman Koil at Nagamarai, Pennagaram Taluk, Dharmapuri District based on the petitioner's representation dated 24.06.2019.

O R D E R

This petition has been filed to direct the 2nd respondent To Give The Bandobust for permission to conduct the cultural programme on 27.06.2019 in the event of Gurukakalaianur Arulmighu Sri Maha Sakthi Mariamman Koil at Nagamarai, Pennagaram Taluk, Dharmapuri District based on the petitioner's representation dated 24.06.2019.

2.Heard the learned counsel appearing for the petitioner and the learned Additional Public Prosecutor appearing for the respondent.

3.The learned Additional Public Prosecutor, on instructions, would submit that there is likelihood of arising law and order problem.

4.A mere apprehension cannot be a ground to reject the representation. There is absolutely no material before this Court to hold that there will be a law and order problem in the event of permission being granted. In such view of the matter, the petitioner is permitted to conduct cultural programme in the event of Gurukakalaianur Arulmighu Sri Maha Sakthi Mariamman Koil at Nagamarai, Pennagaram Taluk, Dharmapuri District, however with the following conditions:-

(a) The cultural programme in connection with the event of Gurukakalaianur Arulmighu Sri Maha Sakthi Mariamman Koil at Nagamarai, Pennagaram Taluk, Dharmapuri District, on 27.06.2019 at 06.00 PM to 11.00 PM.

(b) The petitioner shall pay a cost of Rs.10,000/- (Rupees Ten Thousand only) to the respondent police towards police protection.

(c) There should not be any kind of obscene dance or vulgar dialogues during the performance, by anyone of the participants.

(d) Double meaning songs should not be played so as to spoil the minds of students and youths.

(e) No dance or songs, touching upon any political party or religion or community or caste shall be played.

(f) No flex boards in support of any political party or communal leader, shall be erected at the premises of the programme.

(g) The function shall not affect either religious or communal harmony and shall be conducted without any discrimination based on caste.

(h) If there is violation of any one of the conditions imposed, the concerned police officer is at liberty to take necessary action, as per law and stop such performance forthwith; and

(i) Similarly, the police is directed to stop the dance programme, if it is played beyond the permitted time limit.

(j) The respondent is directed to issue necessary permission, incorporating the above conditions.

5. With the above directions, this Criminal Original Petition stands allowed.

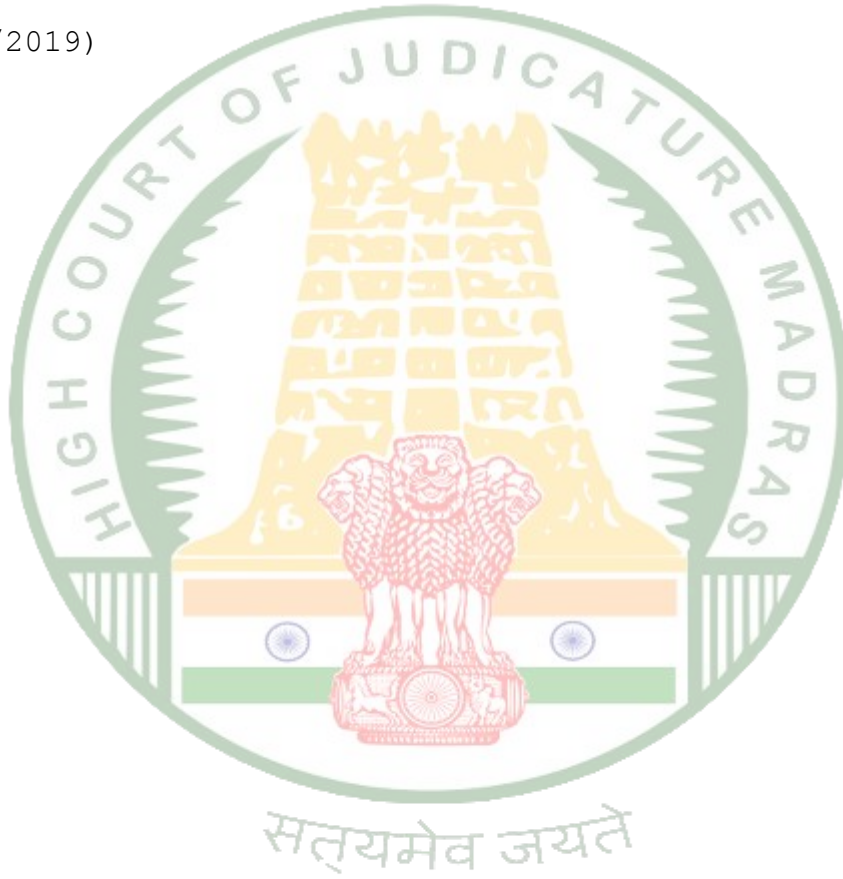
