O R D E R

This petition has been filed for a direction to the respondent Police to consider the representation made by the petitioner dated 12.06.2019 and to remove the name of the petitioner from the History Sheet maintained by the respondent police.

2.The learned counsel for the petitioner submitted that the petitioner is running a Proprietorship concern and is also involved in social welfare activities. Some people who are enemical to the petitioner have given false complaints and this petitioner was also added an accused in Crime No.3 of 2016 and Crime No.8 of 2016. Based on the same, the respondent police opened a history sheet against the petitioner in H.S.No.1 of 2017 and the same is being kept pending till date. Therefore, the petitioner has made a representation to the respondent on 12.06.2019 to remove the name of the petitioner from the history sheet.

3.The learned Additional Public Prosecutor submitted that there are two cases pending against the petitioner and in one case a final report has been filed and in the other case investigation is still pending.



4.This Court has carefully considered the submissions made on either side and also the materials available on record.

5.Taking into consideration the facts and circumstances of the case, there shall be a direction to the respondent police to consider the representation dated 12.06.2019 made by the petitioner to remove the name of the petitioner from the history sheet and deal with the same in accordance with the guidelines given by this Court in the case of Sabari @ Sabarigiri vs. Assistant Commissioner of Police, Annanagar (L and O) Range, Madurai City, Madurai and others reported in (2018) 4 MLJ (Crl.) 585. This process shall be completed by the respondent police within a period of six weeks from the date of receipt of a copy of this order.

6.This Criminal Original Petition is disposed of with the above direction.
