ORDER

This Criminal Original Petition has been filed to recall the non bailable warrant issued by the Judicial Magistrate Fast Track Court, Tiruppur, by an order dated 28.05.2019 against the petitioner in C.C.No.118 of 2015.

2. The petitioner is arrayed as accused in C.C.No.118 of 2015, on the file of the Judicial Magistrate Fast Track Court, Tiruppur, for the offence punishable under Section 138 of the Negotiable Instruments Act.

3. The petitioner was absent during the trial in C.C.No.118 of 2015 on the file of the Judicial Magistrate Fast Track Court, Tiruppur. Therefore, non bailable warrant came to be issued on 28.05.2019.

4. The learned counsel appearing for the petitioner undertake that the petitioner shall appear before the Court below regularly on all future hearing dates without fail.

Fast Track Court, Tiruppur, within a period of two weeks from today and to file a petition to recall the NBW issued against him. The concerned Magistrate is directed to consider the same on merits and pass orders on the same day.

6. Accordingly, the Criminal Original Petition stands disposed of.

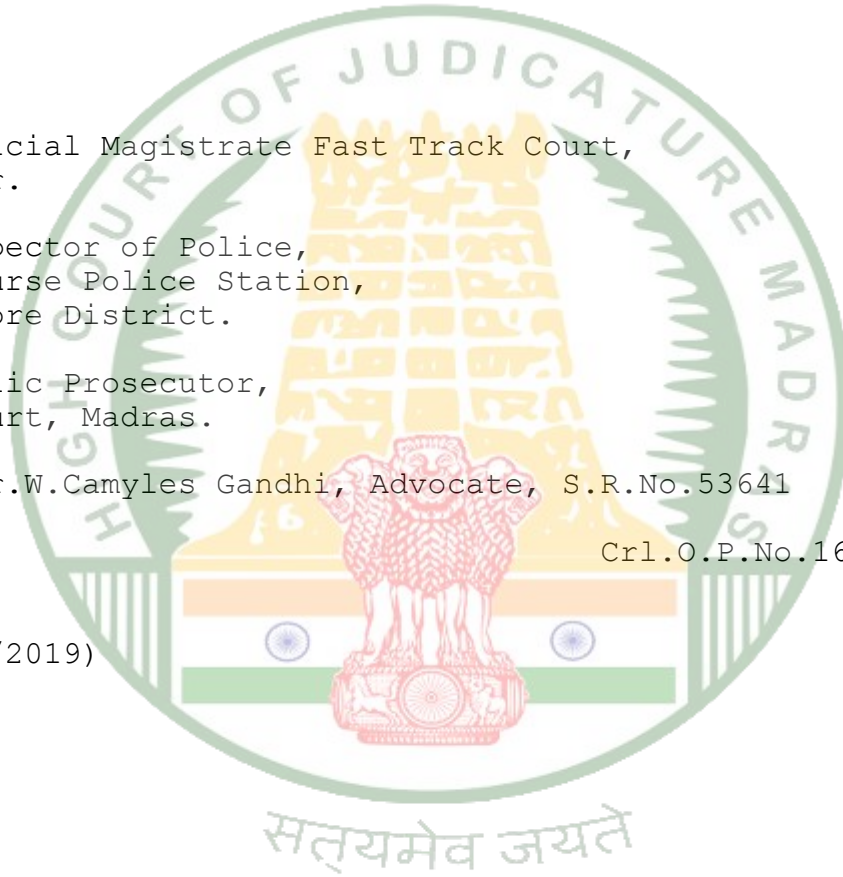
