2. Accordingly, this Civil Revision Petition is dismissed for non-prosecution. No costs.

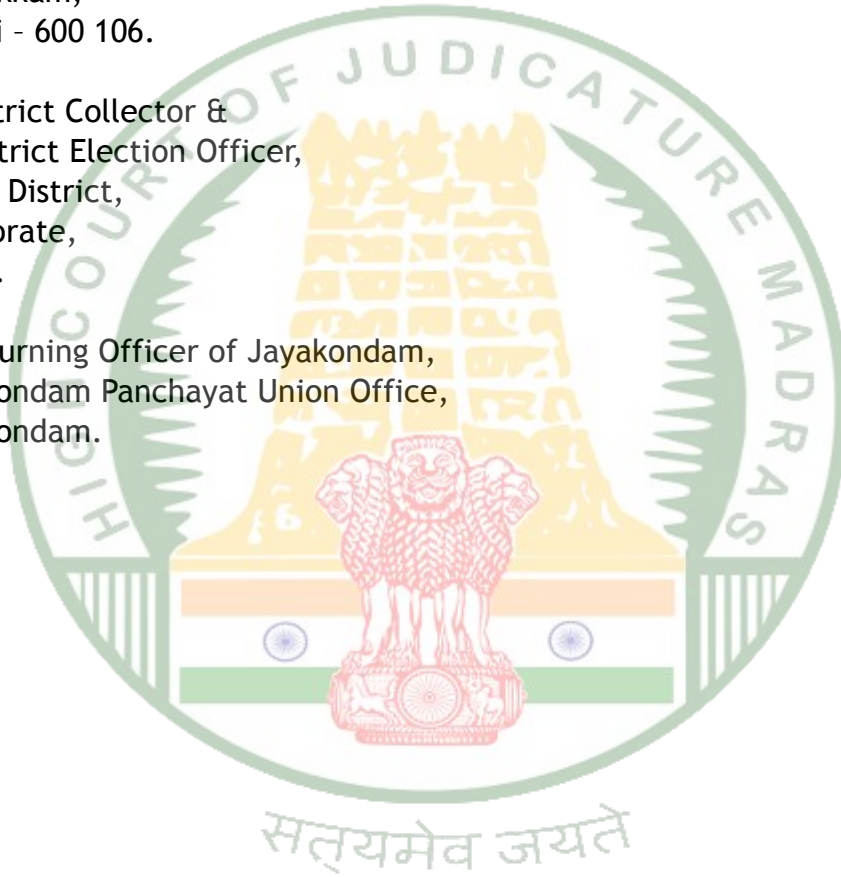

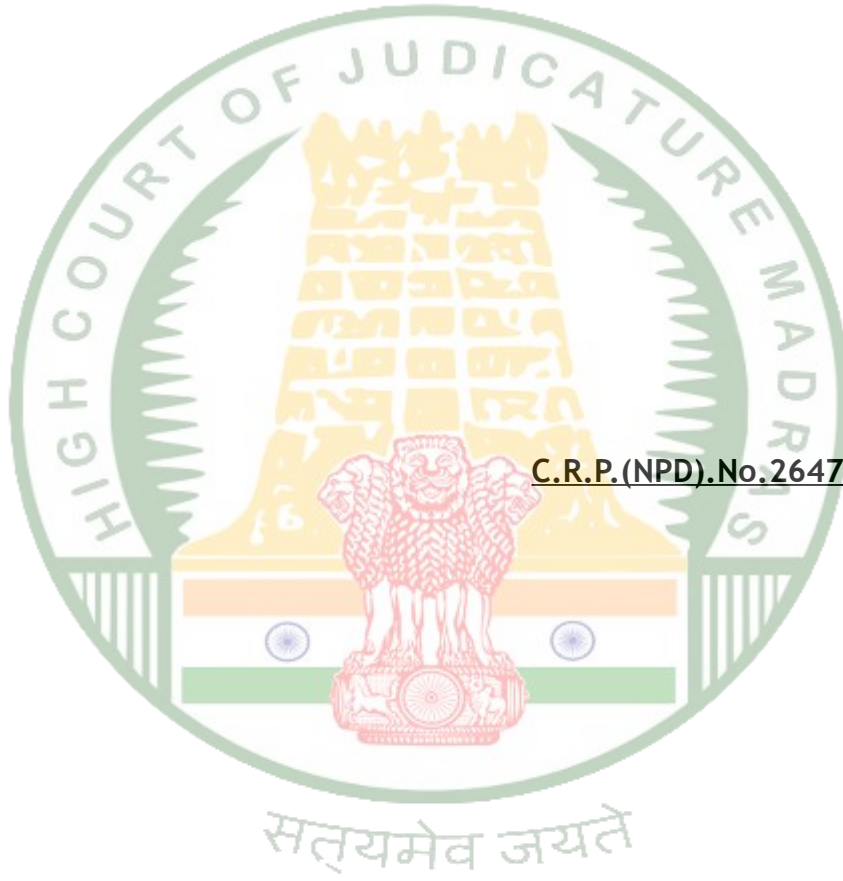
