Prayer in W.P. No. 18380 of 2019:- Writ Petitions filed under Article 226 of the Constitution of India, praying to issue a Writ of Mandamus, directing the Respondent to issue Computerized Patta in the Petitioner's name instead of manual Patta for the land comprised in Old Survey No. 96/3, New Survey No. 66, Saligramam Village, Egmore-Nungambakkam Taluk, Chennai, land measuring to an extent of 1720 Sq. ft. (0.03 cents) as per Patta of Saligramam Village, Egmore-Nungambakkam Taluk, Chennai.

Prayer in W.P. No. 18699 of 2019:- Writ Petitions filed under Article 226 of the Constitution of India, praying to issue a Writ of Mandamus, directing the Respondent to issue Computerized Patta in the Petitioner's name instead of manual Patta for the land bearing Plot No. 16 and 17, Ma. Po. Si. Street, Anna Colony, Saligramam, Chennai - 600 093, Land measuring to an extent of 80 Sq. ft. (0.03 cents) respectively, so the total extent for both the plot is measuring about 1136 Sq. ft. of Saligramam Village, Egmore-Nungambakkam Taluk, Chennai.
