It is hereby brought to the notice of all the concerned that, in compliance of Hon'ble CESTAT Order No.A/85328/2019 dated 19.02.2019, the revocation of Customs Broker Licence of CB M/s Geeta Clearing and Forwarding Pvt. Ltd. (CB No.11/927) [PAN No.AACCG9600M] ordered vide Order-in-Original CAO No.10/CAC/PCC(G)/SKD/CBS (admn) dated 23.07.2018 issued by the Commissioner of Customs (General), NCH Mumbai-I is withdrawn and the CB License is re-stored.'

3. Recording the same, the order-in-original dated 04.11.2015 stands set aside and the Writ Petition is allowed. Connected Miscellaneous Petition is closed. No costs.
