Prayer: Writ Petition filed under Article 226 of the Constitution of India, praying to issue a Writ of Certiorarified Mandamus, calling for the records in impugned order in Petition No.1101/2019/RDP/DP dated 09.02.2019 passed by the 1st respondent herein and quash the same and consequently direct the 3rd respondent to conduct investigation and take necessary prosecution action against the offenders for their irregularities committed in Mahatma Gandhi National Rural Employment Guarantee Act, 2005, MGNREGA (100 Days Employment Scheme) and Individual Household Latrine (IHHL Schemes in the K.Vetrappatti Village Panchayat, Harur Block and Taluk, Dharmapuri District.
