that too original petition, which has been already been disposed of. Hence, both these applications are dismissed.

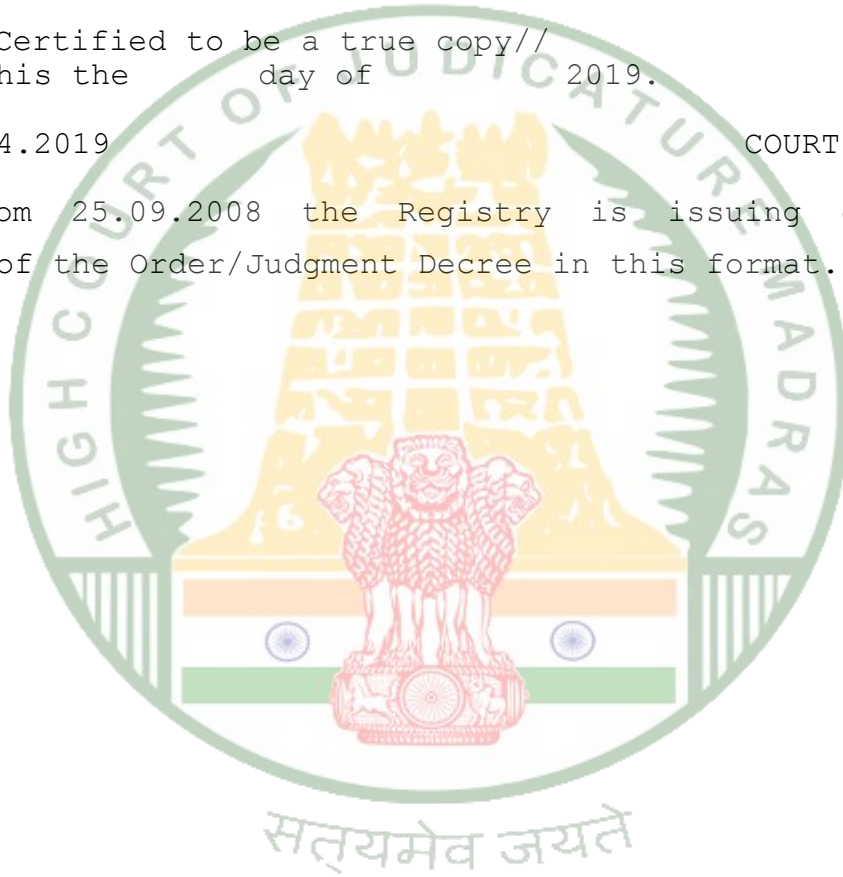
