4. This Civil Miscellaneous Appeal is dismissed accordingly. Consequently, connected Miscellaneous Petition is closed, if any.

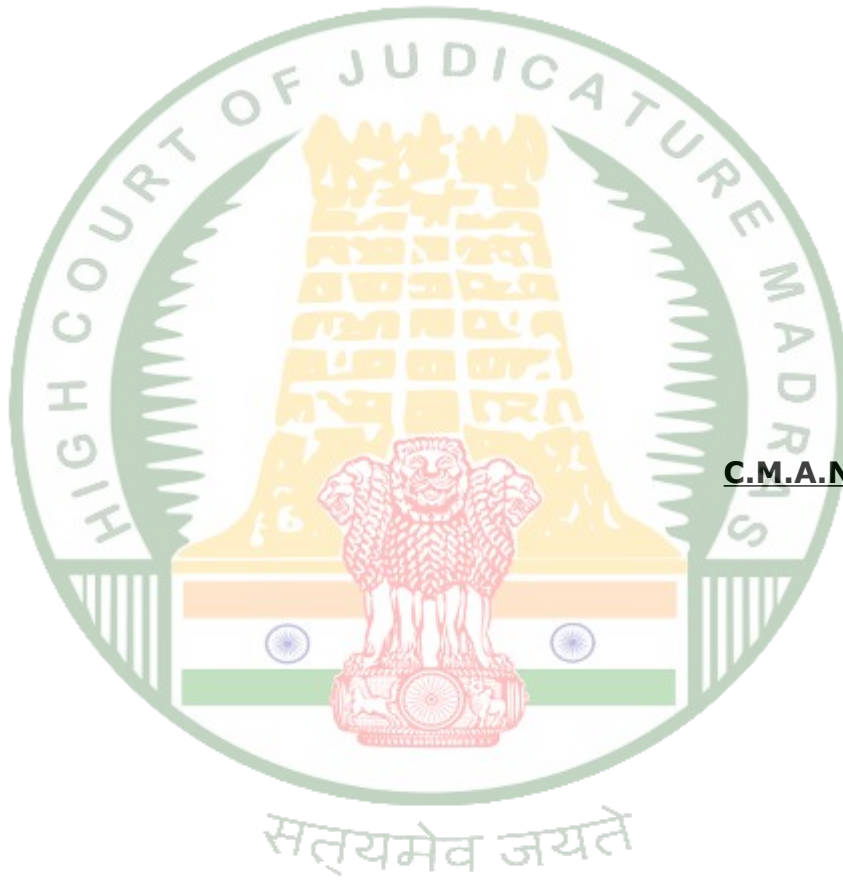
