This Court has suspended the sentence and released the petitioner on bail on certain conditions, one of which is that the petitioner shall report before the trial Court on the first working day of every month. This petition has been filed for relaxing the said condition.

2.In the opinion of this Court, the said condition cannot be relaxed in toto and this petition stands dismissed. However, liberty is granted to the petitioner to file an application under Section 317 Cr.P.C., if the petitioner is not able to appear on any particular day and appear before the Magistrate on any other day as determined by the Magistrate in lieu of the day on which the petitioner is absent.
