Considering the submission made by the learned counsel appearing for the parties, without going into the merits of this case, this Court is inclined to direct the 2nd respondent Bank to consider the petitioner's representation dated 04.04.2014, and pass appropriate orders on merits and in accordance with law after affording opportunity to the petitioner and any other interested person as expeditiously as possible, preferably within a period of twelve weeks from the date of receipt of a copy of this order.

4. With the above direction, this writ petition is disposed of. No costs.
