Order : These petitions coming on for orders upon perusing the petition and the affidavits filed in support thereof and upon hearing the arguments of M/S.S.RAVEEKUMAR, Advocate for the petitioner and of MR.J.KUMARAN, GOVERNMENT ADVOCATE (PONDY) on behalf of the 1 & 2 Respondents the court made the following

The impugned order is passed with reference to the CCS (CCA) Rules, 1965. This apart, the impugned order of suspension has already been revoked. This writ petition is confined only with regard to the impugned charge memo, which was issued under the CCS (CCA) Rules.

2. In view of the fact that the Pondicherry matters are notified under the Administrative Tribunals Act, the petitioner has to adjudicate all the issues before the Central Administrative Tribunal, Chennai Bench.

3. Registry is directed to transfer all the case papers to the Central Administrative Tribunal, Chennai Bench for further adjudication.
