O R D E R

Pursuant to the directions of this Court, the Director of Adi-Dravidar Welfare, Chepauk, Chennai, issued circular in proceedings dated 04.04.2019, instructing the Competent Authorities / Sub-ordinate Officials to conclude the disciplinary proceedings without causing undue delay.

2. In view of the circular issued by the Head of the Department, the case of the writ petitioner was also taken up for proceeding with the disciplinary proceedings and accordingly, disciplinary proceedings against the writ petitioner was concluded and an order of punishment was issued in proceedings dated 21.04.2019, imposing the punishment of stoppage of increment and in respect of the period in which the writ petitioner has not worked, no pay was granted by adopting the method of "No Pay No Work".

3. In view of the fact that the disciplinary proceedings initiated against the writ petitioner has been concluded, no further adjudication is required in respect of the grounds raised in the present writ petition.

4. Accordingly, the present writ petition stands closed. No costs. Consequently, connected miscellaneous petitions are closed.
