KRITIKA KAMAL P, Govt. Advocate (Crl. Side) on behalf of the Respondent the court made the following order:-

This is the second petition for suspension of sentence and bail and the earlier petition in Crl.M.P.No.13561 of 2018 in Crl.A.No.618 of 2018 seeking suspension of sentence and bail has been dismissed by this Court on 10.12.2018 in view of well considered order dated 07.06.2018 passed by the Trial Court in S.C.No.233 of 2016.

2. Even now, there is no change in the fact situation, warranting grant of bail in a case of this nature, where the victim was a mentally challenged girl.

In the result, this petition is dismissed. Registry is directed to call for the records, prepare the typed set of papers and post the main appeal in the last week of August, 2019, under the caption "for final hearing".

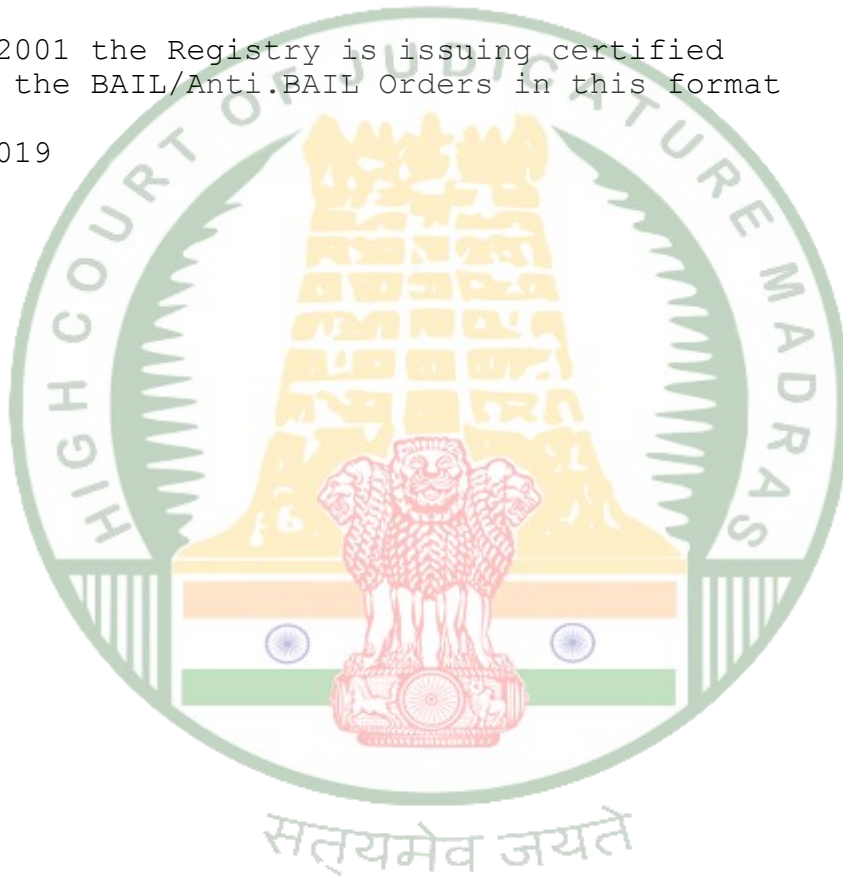
