2. Challenging the award dated 12.09.2013 rejecting the approval petition and directing the reinstatement of full backwages. The Management of Tamilnadu State Transport Corporation, Villupuram has filed the instant writ petition.

Today in the National Lok Adalat, both parties have entered into a settlement wherein the worker has agreed the modification of the award restricting his claim only for reinstatement and forgoing the backwages. It is informed that the respondent has already attained the superannuation and his retirement benefit would be given forthwith. In view of the above, Writ petition is disposed of. Consequently, connected Miscellaneous Petition is also closed.

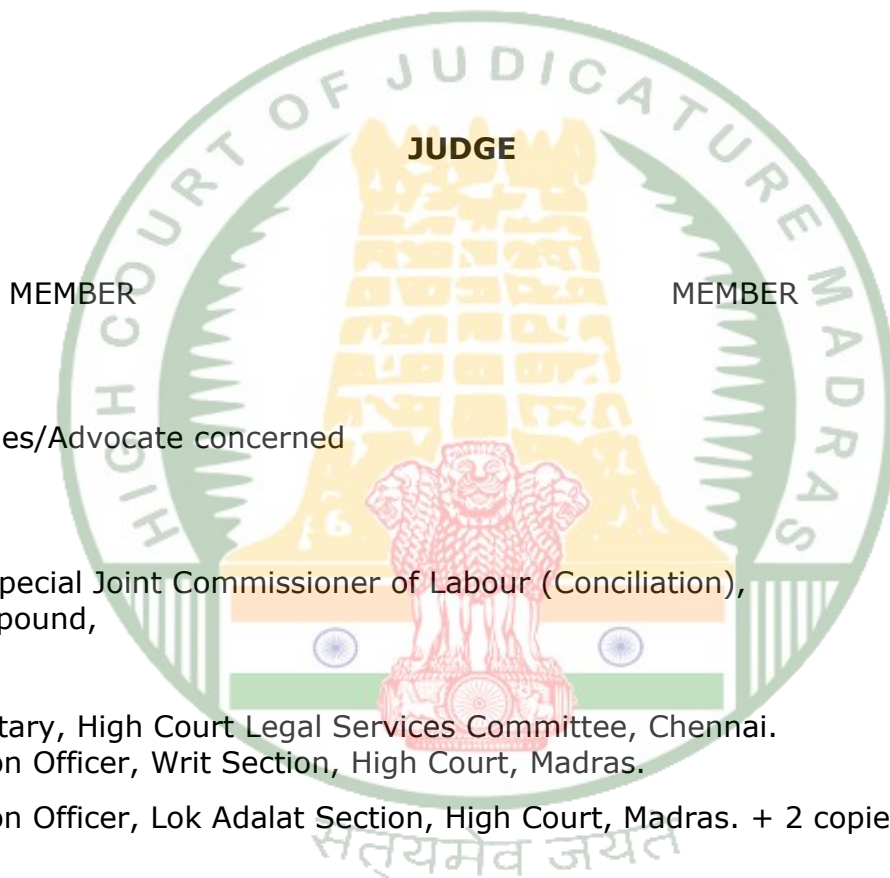
