When it was pointed out that the nature of relief sought by the Petitioner in the representation dated 29.06.2019 sought to be directed to be disposed by the First and Second Respondents in these Writ Petitions, could not be entertained under Section 36 of the Tamil Nadu Societies Registration Act, 1975, in view of the decision of the Full Bench of this Court in C.M.S. Evangelical Suvi David Memorial Higher Secondary School Committee -vs- District Registrar, Cheranmahadevi [(2005) 2 LW 550] and the decisions of the Division Benches of this Court following the same in V. Sobana Kumar -vs- District Registrar, Marthandam [(2008) 4 LW 760], C.M.S. Evangelical Suvi David Memorial Higher Secondary School Committee -vs- District Registrar, Cheranmahadevi [(2008) 4 LW 1080] and C. Dharmalingam -vs- District Registrar, Madurai [(2010) 3 CTC 390], Learned Senior Counsel appearing for the Petitioners seeks permission of this Court to withdraw these Writ Petitions with liberty to pursue the legal remedy for the same before the competent forum and has made an endorsement to that effect, which is recorded.

2. Accordingly, these Writ Petitions are dismissed as withdrawn granting such liberty. Consequently, connected Miscellaneous Petitions are closed. No costs.
