Petition filed under Article 226 of the Constitution of India, to issue a Writ of Habeas Corpus calling for the entire records relating to the petitioner's brother detention under Tamil Nadu Act 14 of 1982 vide detention order, dated 29.06.2019 on the file of the second respondent herein made in proceedings Memo C.No.56/G/IS/2019, quash the same as illegal and consequently direct the respondents herein to produce the petitioner's brother namely J.Prasath @ Daniel Prasath, S/o. Jayaraj, aged 31 years, before this Court and set the petitioner's brother at liberty from detention, now the petitioner's brother detained at Central Prison, Coimbatore.

The petitioner challenges the impugned order of detention in C.No.56/G/IS/2019, dated 29.06.2019, detaining his brother as "Goonda", as contemplated under Section 2(f) of the Tamil Nadu Act 14 of 1982.

The learned Additional Public Prosecutor reports that the order of detention passed against the detenu has been revoked by the Government by its order in G.O.Rt.No.2989 Home, Prohibition and Excise (XII) Department, dated 16.08.2019 and he has also produced a copy of the Government Order. Recording the same, this Habeas Corpus Petition stands closed.
