PRAYER: Writ Petition filed under Article 226 of the Constitution of India praying to issue a Writ of Declaration, declaring the action of the respondents in inviting application and trying to fill the 4000 post of Helper by direct recruitment without promoting the qualified Mazdoors as illegal and consequently direct the respondents to promote the petitioners to the post of Helper in accordance with Per.B.P.(F.B.).No.45, Administrative Branch dated 06.09.2007 and which have been implemented partially in respect of Mazdoors working in the Distribution Circle, General Construction Circle and Wind Energy Development Circle through (Per.)FB.TANGEDCO Proceedings No.9,

Administrative Branch, dated 23.05.2012, within the time frame stipulated by this Court and consequently, direct the respondents to promote the petitioners to the post of Helper in accordance with Per.B.P.(F.B).No.45, Administrative Branch dated 06.09.2007 and which have been implemented partially in respect of Mazdoors working in the Distribution Circle, General Construction Circle and Wind Energy Development Circle through (Per.)FB. TANGEDCO Proceedings No.9, Administrative Branch, dated 23.05.2012, within the time frame stipulated by this Court.

### ORDER

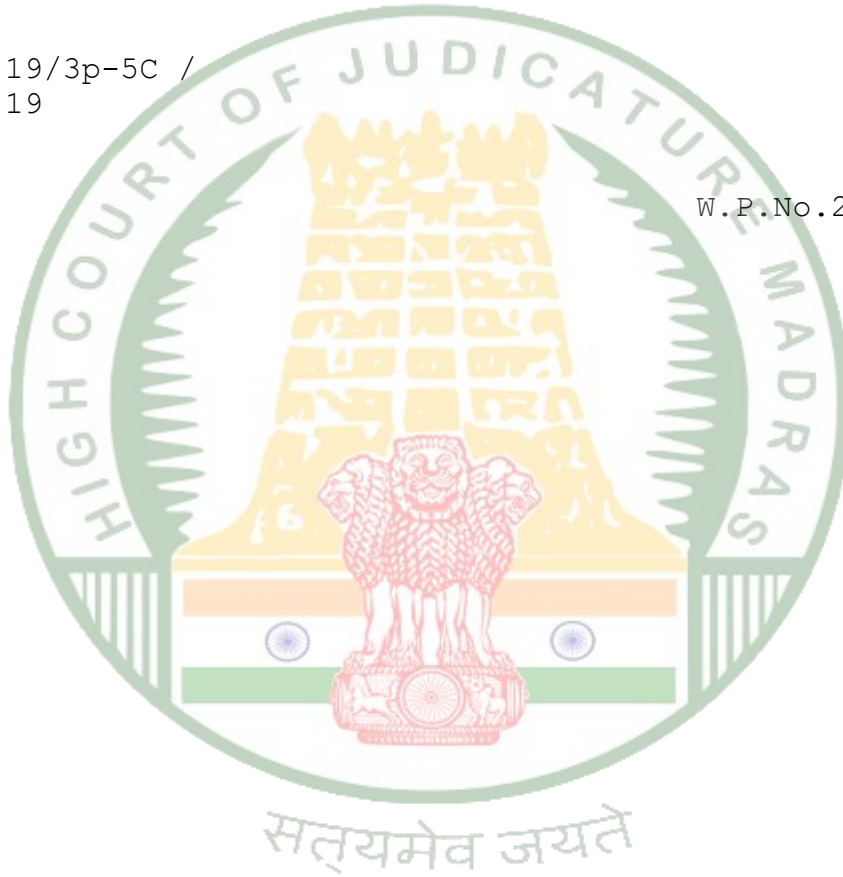
