This Writ Petition has been filed seeking to quash the proceedings in Na.Ka.No.2229/m/1/2014 dated 11.07.2014 passed by

the fourth respondent and to direct the respondents 1 to 4 to regularize the services of the petitioner in Permanent vacancy of Night Watchman post at Government Girls Higher Secondary School at Gummidipoondi or in any other school where there is a permanent vacancy of any suitable post, with all monetary benefits and other service benefits from the date of initial appointment.
