2. The petitioner has prayed that directions be issued to respondents 1 to 4 to remove the illegal encroachment made by the fifth respondent on Government/Gramanatham land bearing Survey No.994/13 at S.Mudduganapalli Village, Hosur Taluk, Krishnagiri District.

3. The learned Government Advocate representing respondents 1 to 4 has stated that in relation to the said encroachment, notice under Section 6 of the Tamil Nadu Land Encroachment Act, 1905 has been issued to the fifth respondent.

4. Thus, it is seen that the authorities are taking action in relation to the encroachment.

In view of the above, no further orders are necessary at this stage and this writ petition is closed. No costs.

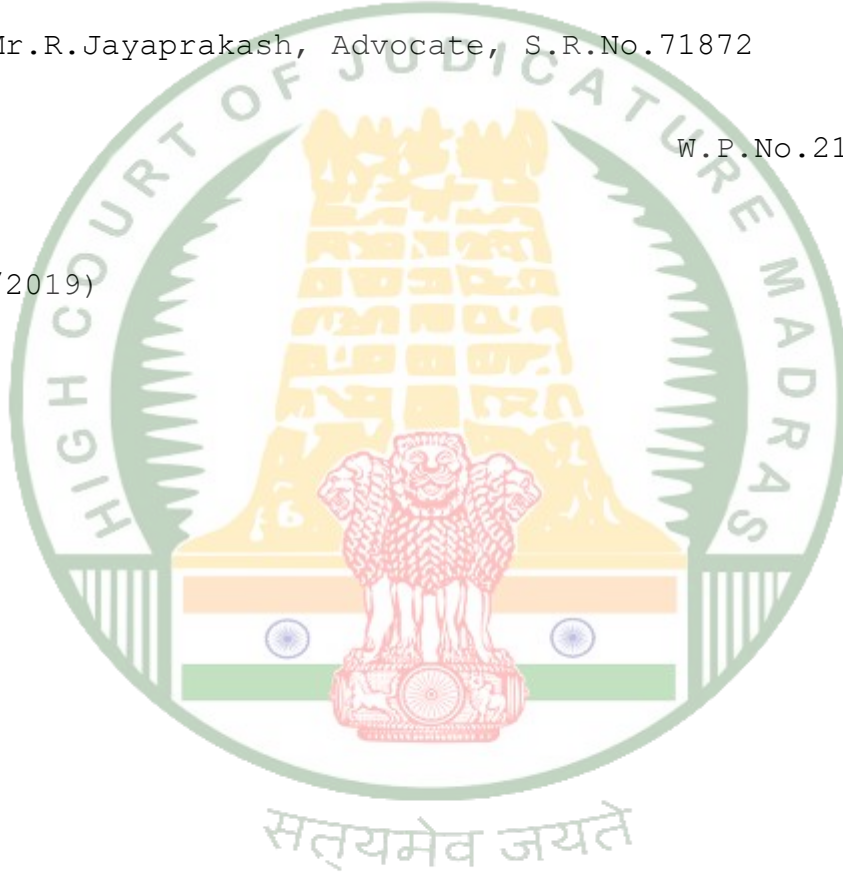
